Staying the course of designing and implementing a fully inclusive experience for students with intellectual disability within our respective programs can be a challenge if we fall prey to the “chatter” that exists within our culture. The “chatter” is what I affectionately term words and ideas that are not based on what research is telling us about students within our programs. Specifically, the topic of a specialized course separate from those offered through the typical college catalogue on our campuses, is a best practice. Best practice for whom?

[ThinkCollege](#) shares a great deal of information regarding best practices, and to date, they have not shared that specialized courses are a best practice. In fact, in an analysis of their data collection, they have found that programs with specialized courses are producing employment opportunities for students who complete the program that are not as favorable as those who participate in fully inclusive college programs.

Too often, best practice is confused with accepted practice. Accepted practices that exist within our inclusive postsecondary education programs include in some instances, some specialized courses just for students with intellectual challenges. While there are groups who accept this practice of segregating students based upon their IQ score or cognitive functioning, that doesn't necessarily qualify it as a best practice. In fact, Dan Habib's latest documentary, "[Intelligent Lives](#)" challenges the very notion of what determines an intellectual challenge.
